

THE CONSTITUTION OF THE BUTLER UNIVERSITY WOMEN'S  
INTERCOLLEGIATE VOLLEYBALL CLUB

ARTICLE I. NAME

*Section 1.* – The name of this organization shall be the Butler University Women's Intercollegiate Volleyball Club.

ARTICLE II. PURPOSE

*Section 1.* – The Butler University Women's Intercollegiate Volleyball Club is organized to provide students with an opportunity for a competitive volleyball program. The priority of the organization is the betterment of its members through experiencing the satisfactions and managing the tribulations of team development and competitive play. This includes exercising self-discipline and loyalty, and striving for excellence. All members of the team and those others associated with this organization shall conduct themselves in such a manner as to encourage the exemplification of the endeavor.

ARTICLE III. MEMBERSHIP

*Section 1.* – Tryouts for membership on the Butler University Women's Intercollegiate Volleyball Club shall be open to all female undergraduate or graduate students enrolled at Butler University.

*Section 2.* – To obtain membership in the Butler University Women's Intercollegiate Volleyball Club, a student must meet all financial obligations appropriate to this organization.

*Section 3.* – If the number of participants in the Butler University Women's Intercollegiate Volleyball Club exceeds twenty members, the Board of Directors will have the authority to make cuts.

ARTICLE IV. VOTING

*Section 1.* – All voting shall require a majority of those present and eligible to vote. Only members of the Butler University Women's Intercollegiate Volleyball Club as defined in Article II, Section 2 are eligible to vote. The president shall vote only in the event of a tie.

*Section 2.* – Voting for a new Board of Directors for the Butler University Women's Intercollegiate Volleyball Club will be conducted during the last meeting of the spring semester each year.

ARTICLE V. STRUCTURE

*Section 1.* -- The administrative authority of the Butler University Women's Intercollegiate Volleyball Club shall be vested in an advisor who is a member of the Butler University faculty or administration.

*Section 2.* -- The governing body, which is responsible for all business and activities of the Butler University Women's Intercollegiate Volleyball Club, shall be the Board of Directors.

*Section 3.* -- The Board of Directors shall be composed of a President, Vice President, Secretary, and Treasurer who will act under the supervision of the Advisor.

*Section 4.* -- The Board of Directors will serve a term of one year and will be voted upon as stated in Article IV, Section 2.

## ARTICLE VI. DUTIES

*Section 1.* -- The President will run all meetings and organize events with the help of the officers. The president will also lead the officers in deciding acceptance or termination of new members.

*Section 2.* -- The vice-president will assist the president in running meetings and organizing events. The vice-president will act as the president if the president need be absent from a meeting or event.

*Section 3.* -- The secretary will record minutes of all meetings and supervise all correspondence.

*Section 4.* -- The treasurer will collect all dues and maintain financial accounts and records for the Butler University Women's Intercollegiate Volleyball Club as well as pay bills sanctioned by the organization.

## ARTICLE VII. MEETINGS

*Section 1.* -- All meetings will be announced through email notices. New member recruitment meetings will be announced by pin ups on campus bulletin boards and through email.

*Section 2.* -- There will be at least one officer meeting of the Butler University Women's Intercollegiate Volleyball Club each month.

## ARTICLE VIII. PARLIAMENTARY

*Section 1.* -- The Butler University Women's Intercollegiate Volleyball Club follows parliamentary procedure and Butler University policies as defined in the most current Butler University student handbook.
